



Interreg IT-HR CBC Programme 2021-2027

The Italy-Croatia Programme has a focus on the Blue Economy. It is a vital resource for Italy and Croatia, but the joint Adriatic Sea basin faces challenges with overfishing, pollution and climate change, which require sustainable management.

Italy-Croatia programme **approach** to blue economy:

The blue economy involves using marine resources in a sustainable way to foster economic growth, improve people's livelihoods and employment prospects, and maintain healthy marine ecosystems.



Blue economy in the Interreg IT-HR 21-27 Programme IP content:

JOINT PROGRAMME STRATEGY: MAIN DEVELOPMENT CHALLENGES AND POLICY RESPONSES

«Blue economy represents a crucial sector for the Programme area.

Blue Economy should play an **important role**, as reported during the consultation process, due to its strong focus on marine living resources, coastal and island tourism, maritime transport, extraction of natural resources.»



2.3 Is the project <u>clearly</u> and <u>consistently</u> contributing to specified EUSAIR macro-regional strategy pillar objectives and flagships?

2.4 Are **complementarities** and **synergies** between the project proposal and projects <u>supported by other programmes</u> and initiatives clearly demonstrated?

Interreg IT-HR CBC Programme 2021-2027: Operations Of Strategic Importance (OSI)

Foreseen by Regulation 1060/2021 as «operations that provide a **significant contribution** to the achievement of the objectives of a Programme and which is **subject to particular monitoring and communication measures**» (art. 1)

The foreseen categories of OSIs are the following two:

- 1. SMEs Facility. The aim of this instrument is to target specific domains of the <u>Blue Economy</u> with a high potential in terms of growth, innovation and reinforcement of skills based on CB business cooperation between SMEs/start-ups
- 2. Further Operation(s) of Strategic Importance that could be funded in relation to the topics proposed in <u>the EUSAIR</u> <u>flagship themes</u> mentioned for each SO (excluding SO 1.1, 1.4 and ISO1
