# The North Adriatic Fishing District

### What is the District?

It can be defined as a tool for shared management and concerted activity of the Northern Adriatic fish industry at a political, economic, social and environmental level in compliance with the legislative provisions of the Common Fisheries Policy

In fact, it is possible to identify homogeneous areas for fishing activities to which common management rules can be applied.

On this basis, the Ministerial Decrees of 23 February 2010 and 27 February 2012 establishing the Fishing District were approved






The main aim of The North Adriatic Fishing District is promoting partnerships with producers and businesses in the fisheries sector supply chains for the common development of the actions envisaged in the policies and interventions identified and shared between the Ministry and the three Regions.

# The North Adriatic Fishing District

The AIMS of the Regions of the District are essentially linked to a shared and sustainable management of biological resources (with a view to respecting the specificities of the production systems, traditions and profitability of companies)

The problems are:

- the production crises
- the supply chain and health links
- the issues connected to marketing and commercial valorisation of the product
- the management problems of companies
- the regulations and constraints imposed by the EU

- the excessive anthropisation of the marine strip within three miles, today more than ever require management efficient and coordinated local fisheries policies.

The management of the biological fishing shutdown, for example, finds in the peculiarities of the upper Adriatic area the need for different periods compared to the entire Adriatic.

For this reason, the activity of promoting the partnership towards the cross-border regions of the upper Adriatic, the Istrian Region and the Litoral-Mountain County in Croatia and Slovenia, is more timely and fundamental than ever.

Their involvement, once the limits of a political-institutional nature have been overcome, will be able to give the District the breath that the EU itself promotes in favor of coastal communities and fishing companies that operate in a common basin for traditions, types of fishing, problems and needs.



The district finds its roots in the Northern Adriatic partnership which was born in 2001 and since then has seen the individual Regions engaged in the consolidation of their cross-border activity thanks to various financed and completed projects and others that are in the start-up phase.

> The Emilia-Romagna, Friuli Venezia Giulia and Veneto Regions, with the Municipality of Izola in Slovenia, the Istrian Region and the Litoral-Mountain County in Croatia, have started a fruitful collaboration relationship to undertake a coordinated process of structural, infrastructural and fisheries management.

The PRIZEFISH project idea builds on the rationale to implement a cross-border, territorial and socio-economic developmental change in the cooperative renewable exploitation of Adriatic fishery resources and consequently in the long-term benefits on the Adriatic marine ecosystems. PRIZEFISH builds on knowledge that were capitalized on abundant synergies with several previous and ongoing cooperation projects in the fishery sector its overall objective to tackle the dual territorial challenge for Italian and Croatian Adriatic fishing SMEs and Producer Organizations (POs) to be more sustainable and to increase their economic competitiveness in the seafood markets, by developing and piloting innovative fishery products with addedvalue given by ecolabels fulfilling requirements of environmental, economic and social sustainability.





This project is example of cooperation of various experts, members of representatives of local, regional authorities, educational institutions, international environmental organizations, who will jointly evaluate their already developed good practices for a sustainable use of marine and coastal resources.

To ensure such sustainability, it is necessary to establish a smart coastal management system to assist the Maritime Spatial Planning. All involved PPs will work together to establish guidelines for preserving the wealth of the Adriatic Sea in order to reap maximum economic benefits while protecting the marine ecosystem.

In accordance to the EUSAIR Pillar3 and the relevant Flagship the so far achieved experiences from the projects SOUNDSCAPE, ECOSS, ECOMAP, NET4MPLASTIC, DORY, ML-REPAIR, SASPAS will be amalgamated to develop sustainable growth, to decrease pollution and contamination, and protect the unique biodiversity of the Adriatic Sea.





Lifeel is the first European eel conservation project involving actions in the area of the Po River (Italy) and the Nesto River (Greece).

The global population of Anguilla anguilla is at risk of extinction, due to the fragmentation of the river network and interactions with fisheries and aquaculture. Lifeel is taking actions according to a shared approach to problems and the creation of a program of restocking activities for specimens in growth and reproductive age.

Lifeel is a project funded by the European Life Program for a period of 4 years, from 2020 to the end of 2024.

## BLUE FOOD (Test Project)

Preservation of maritime biodiversity by Contrasting BLUE Crab competition with autochthonous species through target new competences, target catching and valorization as Food

Contribute to the restoration of Mediterranean coastal ecosystems through systematization of methods and practices for the targeted capture of the Blue Crab and its enhancement for quality nutritional value, the source of income for the blue economy, with particular attention to smallscale fisheries scale and short food chains for the HORECA sector.

SO 2.7 - Improve the protection and conservation of nature, biodiversity and green infrastructure also in urban areas and reduce all forms of pollution: to achieve this, strong cooperation is needed in order to fill any political gaps, consolidate existing efforts and ensure full implementation of existing legislation.



### MIND EAT (Study Project)

Fostering more circular and sustainable models for the Mediterranean diet

For many years, European Mediterranean countries have worked hard to demonstrate that the Mediterranean diet is one of the best not to mention the best - in the world in terms of its healthy attribution, in addition to its well-known flavors.

However, there is still room for improvement when it comes to the environment and sustainability.

Reports show that there is still too much food waste, lack of circularity/recycling and unsustainable practices, on both sides, supply and demand.

Before specific actions can be taken to address this, some additional studies are needed to assess what potential initiatives could address this challenge.

The project will then implement study activities that can lead to clear conclusions to build a potential further project in the future where these conclusions can be transformed into specific pilot actions.
